*All fees are exclusive of consumption tax (added at the prevailing government rate, currently 10%) and are non-refundable. Payments must be made in Japanese Yen by bank transfer only, with the child's name in English as reference; all bank charges, conversion costs, and shortfalls are the responsibility of the payer. Where tuition is paid by a sponsoring company, parents/guardians remain ultimately responsible for ensuring timely payment. Tuition is due on or before the 25th of the preceding month, and installment deadlines must be met to secure enrollment; failure to complete payment by the specified due date may result in the student's enrollment place being suspended or forfeited until payment is received. Late payments will incur a 10% monthly surcharge, compounded, and students with outstanding balances may be suspended from classes and records withheld until full payment is made. No refunds or credits will be issued for absences, illness, family travel, or school closures due to health, safety, or regulatory requirements. Withdrawal or schedule changes require at least 30 days' written notice, with no mid-month refunds. The school reserves the right to suspend or terminate enrollment for non-payment, repeated late payment, behavioral concerns, or policy violations, with all paid fees non-refundable and outstanding balances payable in full. Additional fees may apply for special projects, field trips, camps, extracurricular activities, or special events. In case of force majeure (including natural disasters, strikes, epidemics, quarantines, or similar circumstances), the school may continue instruction through at-home or online learning, which will be deemed fulfillment of its obligations, with tuition still payable in full. This agreement is governed by the laws of Japan, with disputes subject to the jurisdiction of the Tokyo District Court.
